08/17/2010 – Seneca County Sheriff's Deputies arrested Christopher L. Planty, age 27, of 35 Green Street, Seneca Falls, NY on a bench warrant for fail to pay fines. Planty was arrested by Seneca Falls Police Department while he was walking down Fall St and was turned over to Seneca County Sheriff Deputies at Town of Seneca Falls Court. Planty was arraigned and released without bail and ordered to pay on his fines weekly.
